GENERAL

The specified products were not yet assessed for compliance with all hygienic aspects as inserted in the “Drinkwaterbesluit” (Drinking Water Decree) and outlined in the “Regeling materialen en chemicaliën drink- en warm tapwatervoorziening” (Regulation for Materials and chemicals in drinking water and warm tap water supply), implemented 1 July 2017, as specified in clause 4.2 of the Kiwa guideline BRL-K14018.

APPLICATION AND USE

The electronic (mixing) taps are intended for application in drinking water installations with a static water pressure of maximum 1000 kPa and a maximum water temperature of 75 °C.

The recommended limits for correct operation are a dynamic pressure between 100 kPa and 500 kPa and a water temperature of maximum 65 °C.

MARKING

The Kiwa®-mark products are marked with the wordmark “KIWA”.

Place of the mark: on the body.

Compulsory specifications:

- name or mark of the manufacturer: on the body;
- indication of the acoustic group, if classified: on the body;
- indication of the flow rate class, if classified: on the body;
- Indication for temperature selection.

Method of marking:

- non-erasable;
- visible after assembly.
